The application made will be considered as null and will definitely not be evaluated.

SCHOLARSHIP PAYMENT:

The first payment of scholarship will be paid in October for candidates being notified they have earned a scholarship. The first scholarship payment, will include the scholarship amounts corresponding to the months of September and October as well as the monthly pocket money to be end for one time only at the beginning of each academic year. During the education period, the scholarship is paid from September to May (9 months) and no payment is done for the other months (June, July, August). The payments are made within the first half of the next month.

INTERRUPTION OF SCHOLARSHIP:

The scholarship is granted to the student whose success is documented proven at the end of each academic year all along his/her study period. The scholarship granted to a student whose normal study period ends will interrupted at the end of May.

1. Original of student certificate and Student Identity Document photocopy,
2. Duplex photocopy of the R.T. Identity Card,
3. 2 passport photo taken within the last 6 months,
4. Certificate of identity register copy issued by the civil registry and residence Notification Form
5. Document indicating any registered and possessed title, tax office, traffic registration to be issued by the competent authority where you, your mother and father or spouse lives
6. For the applicant and/or his/her family living in rented house, the rental contract and the bank receipt relating to the rental payment of the last three months (June, July, August 2016),
7. Your criminal record
8. Certificate of achievement,
 - a- Transcript for the ones continuing education in intermediate classes
 - b- For the primary and secondary school students, original or certified copy showing the marks of the previous years
9. Document issued by the education establishment that he/she did not repeat a grade level
10. Document to be received from education establishment that he/she did not have any administrative penalty
11. Regarding the income declaration:
 - a- Salary document approved by the work place for the employed mother, father and spouse if married,
 - b- If they are subjected to income tax, notarized photocopy of tax certificate,
 - c- If they are retired, document issued by the relevant social insurance company indicating the amount they receive as retirement pension,
 - d- Document certified by the chief for the farmers subjected to the exemption,
 - e- Document approved by the Chamber of Agriculture for the farmers not subjected to the exemption,
12. For non-employed mother, father and spouse if married document issued by the institution such as Bağ-Kur, Retirement Fund and SSI indicating they are not registered (It is mandatory to have the TC Identity No / name/ surname mentioned on the document)
13. For brother and sister above 18 years old and living with the family:
 - a- Military service certificate if he went soldiering,
 - b- If they are studying (faculty of open university, undergraduate an postgraduate student included) student certificate to be issued from the school they attend,
 - c- If they are working at the same time, the salary document issued and approved by the work place,
 - d- For the non employed brother and sister, document issued by the institution such as Bağ-Kur, Retirement Fund and SSI indicating they are not registered (It is mandatory to have the TC Identity No / name/ surname mentioned on the document)
14. If the student or mother/father is disabled, a document issued by the relevant establishment stating the situation,
15. For the one whose mother or father get handicapped during their formal duty, became martyr or are state mandated as per the provisions of the Act numbered 2828, official document or notarized photocopy stating the situation,
16. Photocopy / document of the account book of the applicant indicating the bank account details (for applications /student above 18years old, the account shall belong to the student and for students under 18, the bank account shall be at the name of the student or his/her parents or tutor. The documents except the mentioned ones will not be taken into consideration for evaluation).
